People who are members of more than one caving club only need to join BCA once, so if you pay your BCA membership direct or through another club (it is important that you state which club) and provide your BCA number on the application form.

9. Mailing Lists. There is an "Announcement" system that members can use via the Web Master.

10. Membership List. Every year the club produces a members list containing names, addresses and contact details. A paper copy is available from the Membership Secretary and a copy will be available on the 'members area' of the website. You can select what information you wish to include.

11. MCR Callout. For large rescues Mendip Cave Rescue organisation operates a procedure where members of the Mendip clubs may be called upon. Please circle your distance from Mendip, if you are available to be called for a rescue.

12. Some Criteria for Prospective Membership of the Wessex Cave Club

Have a keen and genuine interest in caving and its advancement.

Be known to the proposer and seconder, preferably to have been caving with them.

Be known to be honest and trustworthy.

Be willing to freely help with the maintenance and upkeep of the Club.

Be able to complete an application form sensibly and return it with the correct fee.

13. Club Rule 8.1

"That every person, whether a member of the Club, making use of the services of a guide or guides, or taking part in any activity or expedition organised by the Club, or in which any member of the Club shall take part, shall do so at his or her own risk, and that he or she, or his or her legal personal representatives or assigns or dependants shall have no claim or right of action against the Club, or any member thereof, in respect of any damage, loss or injury (including death) sustained by whomsoever and howsoever caused notwithstanding any negligence of the guide or any members, or the body of members of the Club."
